

The year 2024 was marked by persistent economic challenges for Western economies, significantly affecting their GDP growth rates. Germany's economy faced headwinds, with growth remaining subdued, while the UK recorded a modest growth rate of approximately 0.5% to 1%. The USA and China, however, posted relatively stronger performances, with growth rates around 1.9% and 4.8%, respectively, for 2025, according to IMF forecasts.

In contrast, India's economy continues to shine as a global outlier. By the end of 2024, India's nominal GDP reached approximately US\$ 3.78 trillion, with a per capita GDP of around US\$ 2,880. For the financial year 2024-25, India's real GDP growth is estimated at 6.4% to 7%, making it the fastest-growing major economy, significantly outpacing the projected global average of 2.7%. This robust performance is driven by strong domestic demand, recovering agricultural output, and sustained infrastructure investments, despite a slowdown in the April-June 2024 quarter due to election-related spending constraints.

In 2025, global trade faces uncertainties from the Russia-Ukraine and Israel-Palestine conflicts, plus US-China and US-India tariff tensions, threatening India's export competitiveness. Enhanced logistics and export regulations are vital to sustain momentum. India targets US\$ 1 trillion in merchandise exports by 2030. In Q1 2025 (April-July), total exports hit US\$ 277.63 billion (up 5.23% from 2024), with merchandise exports at US\$ 149.20 billion. Progress in 'Ease of Doing Business' and 'Logistics Performance Index' is key, but India's SDG rank (66/193 in 2024) needs improvement in gender equality and sustainability.

While challenges remain, India is on a promising trajectory in 2025. With robust economic fundamentals, resilient services exports, and proactive reforms, the country is well-positioned to navigate global uncertainties and solidify its role as a key driver of global growth.

Samvardhan-III: A Major Initiative for Child Protection

The first quarter of 2025 marks a significant step forward in child protection with the ongoing implementation of Samvardhan-III, an initiative of the National Commission for Protection of Child Rights (NCPCR) in collaboration with district administrations of Koderma, Giridih, and Dumka.

The National Commission for Protection of Child Rights (NCPCR) launched the Samvardhan-III Action Plan in Koderma, Giridih, and Dumka, Jharkhand, to connect vulnerable children and families with welfare schemes. Inaugurated on June 5, 2024, by NCPCR Chairperson Mr. Priyank Kanoongo at Koderma, the initiative engaged 713 villages through special Gram Sabhas to identify children in 23 high-risk categories. Block-level training from July 18-20, 2024, involved government officials, Anganwadi workers, and NGOs, ensuring access to education, health, and social security schemes to protect children from child marriage, labor, and trafficking.

Rugmark Foundation's Schools: Empowering Children of Carpet-Weaving Families

The Rugmark Foundation, dedicated to eradicating child labor in the carpet industry, operates three vital educational institutions in India: RM Balashraya (a rehabilitation center) in Bhadohi, Barhi Newada in Varanasi, and Handia in Allahabad. As of Q1 2025, these schools collectively serve 334 children from carpet-weaving families, providing a critical pathway to break the cycle of child labor.

These schools address the educational and developmental needs of children whose parents, due to their proximity to the carpet-weaving industry and socio-economic challenges, face the risk of engaging their children in labor at an early age. By offering formal education alongside vocational training in diverse fields, the Rugmark Foundation equips these children with skills for sustainable livelihoods. Additionally, the schools provide medical care, recreational activities, and sports, fostering holistic development and opening new perspectives for a brighter future.



On January 26, 2025, the Rugmark schools celebrated India's Republic Day with flag-hoisting ceremonies, cultural programs, and activities, fostering national pride and unity among students, enriching their educational journey.
